ORDINANCE NO. 280

AN ORDINANCE OF THE TOWNSHIP OF EPHRATA, LANCASTER COUNTY, PENNSYLVANIA, TO AMEND THE ZONING ORDINANCE OF EPHRATA TOWNSHIP, AS AMENDED, TO REQUIRE SIGNS FOR PUBLIC RECREATION AREAS, SCHOOLS, COLLEGES, CHURCHES, OR OTHER SIMILAR PUBLIC INSTITUTIONS IN THE COMMERCIAL AND INDUSTRIAL ZONING DISTRICTS TO COMPLY WITH THE BUSINESS SIGN REQUIREMENTS IN THE UNDERLYING ZONING DISTRICT.

WHEREAS, Ephrata Township has conducted a public hearing to consider an amendment to the Zoning Ordinance of Ephrata Township, as amended (the "Zoning Ordinance"); and

WHEREAS, prior to the public hearing, the proposed amendment was provided to the Ephrata Township Planning Commission and to the Lancaster County Planning Department for comments as provided by law; and

WHEREAS, after a public hearing and after consideration of all information, comments and questions, members of the Board of Supervisors of Ephrata Township have deemed it beneficial to the residents of Ephrata Township and to the promotion of the health, safety, morals, convenience, order and welfare of present and future inhabitants of Ephrata Township to amend the Zoning Ordinance as hereinafter set forth.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED, by the Board of Supervisors of Ephrata Township, Lancaster County, Pennsylvania, as follows:

SECTION 1: The Zoning Ordinance of Ephrata Township, as amended, Article V, Section 507.A.5 shall be deleted in its entirety and replaced with the following language:

- 5. Signs for public recreation areas, schools, colleges, churches, or other similar public institutions or uses, provided that:
 - a. Within the AH, A, RLD, RMD and RHD zones, the area on one (1) side of any such sign shall not exceed twenty (20) square feet.
 - b. Within the C, C-2, I, and I-2 zones, building and freestanding signs shall comply with the requirements of Section 507.A.10 of this Ordinance.

c. Within all zoning districts, not more than one (1) sign may be erected on each street frontage.

SECTION 2: All other provisions of the Zoning Ordinance of Ephrata Township, as amended, not amended or changed shall remain in full force and effect.

SECTION 3: In the event any provision, section, sentence, clause or part of this Ordinance shall be held to be invalid, illegal or unconstitutional by a court of competent jurisdiction, such invalidity, illegality or unconstitutionality shall not affect or impair the remaining provisions, sections, sentences, clauses or parts of this Ordinance, it being the intent of the Board of Supervisors that the remainder of the Ordinance shall be and shall remain in full force and effect.

SECTION 4: This Ordinance shall take effect and be in force from and after its enactment as provided by law.
